She also offered that perhaps allowing 2 Board seats being opened to residents outside the city of Dayton. Ross mentioned DATV already has a supporting city membership which generates some income. He also mentioned DATV's commitment of services is to the city of Dayton and will remain so. S. Ross publicly thanked Marlese for her work. Ross also tasked Board members with speaking with their constituents about serving on the Board. M. Durr moved to continue to make diversity of the Board a goal of the Board. D. Johnson seconded. R. Phillips asked for a vote, motion passed unanimously.
